On the motion of Nara Dahlbacka, seconded by Jan Coppinger, approved the Permit Level for Onsite Consumption, to mirror the previously approved recommendations for Permit Levels for Type 9 and Type 10 licenses.

For recommended Zoning for Permit Levels for Type 9 and 10 licenses, refer to March 13, 2023, Cannabis Ordinance Task Force Final Minutes:

Type 9 Delivery Only:

Major Use Permit: SR\*, C1

Minor Use Permit: APZ\*, A\*, TPZ\*, RL\*, RR\*, PDC, CH, CR, C2, C3, M1, M2, MP, U

Type 10 Retail:

Major Use Permit: SR\*, C1

Minor Use Permit: APZ\*, A\*, TPZ\*, RL\*, RR\*, PDC, CH, CR, C2, C3, M1, M2, MP

\* Allowable only as an incidental use to permitted and licensed commercial cannabis cultivation
