Table 27.11B – Row 1

License Type 4 – Nursery

Cultivation of cannabis solely as a nursery. Nursery starts are not flowering plants.

Minor Use Permit

Base Zone(s): APZ, A, TPZ, RL, RR, SR

Major Use Permit

Base Zone(s): PDC

Table 27.11B – Row 3

License Type N – Manufacturing

Manufacturers that produce edible products or topical products using infusion processes, or other types of cannabis products other than extracts or concentrates. A Type N licensee may also package and label cannabis products on the licensed premises.

Table 27.11B – Row 3

License Type P – Manufacturing

Manufacturers that only package or repackage cannabis products or label or relabel the cannabis product container or wrapper. Manufacturers that engage in packaging or labeling of cannabis products as part of the cannabis manufacturing operation do not need to hold a separate Type P license. (Ordinance Number 3079, December 11, 2018)

Table 27.11B – Row 4

License Type 6 – Manufacturing Level 1

The manufacture cannabis products for cannabis use using nonvolatile solvents, or no solvents, as defined by the Business and Professions Code, Section 40100.

Major Use Permit

Base Zone(s): APZ, A, TPZ, RL, RR, C3, M1, M2, PDC

Not Allowed

Base Zone(s): SR, R1, R2, R3, C1, C2, CR, CH, MP, O, W, U, PDR

Table 27.11B – Row 5

License Type 7 – Manufacturing Level 2

The manufacture cannabis products for cannabis using volatile solvents, as defined by the Business and Professions Code, Section 40100.

Major Use Permit

Base Zone(s): M2

Not Allowed

Base Zone(s): APZ, A, TPZ, RL, RR, SR, R1, R2, R3, C1, C2, C3, CR, CH, M1, MP, O, W, U, PDR, PDC

Recommended Zoning

Major Use Permit: M1, MP



Table 27.11B – Row 6

License Type S – Shared Manufacturing

Type S Manufacturers operate in shared-use facilities and can extract or infuse cannabis and package and label products. Shared-use facilities are places where multiple Type S manufacturers rotate on a schedule and share space and equipment. A Type 7, 6, or N license can register all or part of their manufacturing premises as a shared use facility.

Currently the County of Lake has not enabled the use of Type S licenses.

Recommended Zoning

We recommend allowing Type S facilities wherever manufacturing is allowed.

Minor Use Permit: Type 6, or N - M1, M2, MP

Major Use Permit: Type 7 - M1, M2, MP



Table 27.11B – Row 7

License Type 11 – Distributor

The procurement, sale, and transport of cannabis and cannabis products between entities licensed pursuant to California Code. This license type allows operators to bring their product directly to testing labs.

License Type 13 – Distributor Transport Only

The transport of cannabis goods between entities licensed pursuant to California Code.

License Type 13 – Distributor Transport Only, Self-distribution

The transport of cannabis goods between entities licensed pursuant to California Code.
(Ordinance Number 3079, December 11, 2018)

Cannabis Processor License

DCC Cultivator license for cultivators that only trim, sift, cure, dry, grade, package or label cannabis.

Major Use Permit

Table 27.11B – Row 11

License Type 8 – Cannabis Testing Lab

Testing laboratory: The testing of cannabis for contaminants and concentration of various chemical compounds. (Ordinance Number 3079, December 11, 2018)

Minor Use Permit

Not Allowed

Table 27.11B – Row 12

License Type 12 – Microbusiness

The Type 12 License is for businesses that do at least three of the following activities at one location:

- Cultivation – up to 10,000 total square feet
- Manufacturing – use of non-volatile solvents, mechanical extraction, or infusion
- Distribution or distribution transport-only
- Retail – storefront or non-storefront

License Type 9 – Delivery Only Retail

Table 27.11B – Rows 14-16

License Type 10 – Storefront Retail

A Storefront Retailer has a physical location where cannabis goods are sold. Storefront retailers can also deliver cannabis goods. Consumption lounges are permissible under state law as a designation under a Type 10 license. This allows the consumption of cannabis products purchased onsite as long as it is not visible from any public property or non age-restricted area. Enabling this use would allow On-Site/On Farm Consumption in tasting rooms or lounges.

Temporary Cannabis Events

Temporary Cannabis Events can only be hosted by a person with an Event Organizer license from the State. Events can be hosted in compliance with the jurisdiction's local zoning ordinance. Currently the County of Lake does not address this use type.
