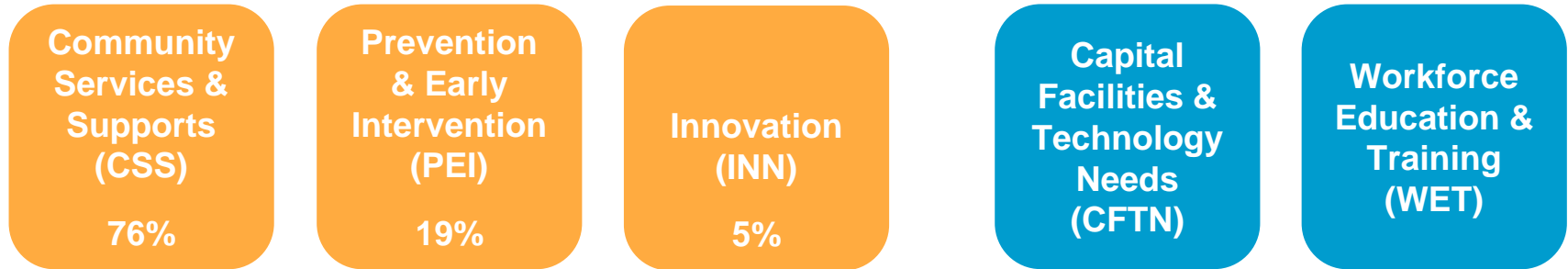

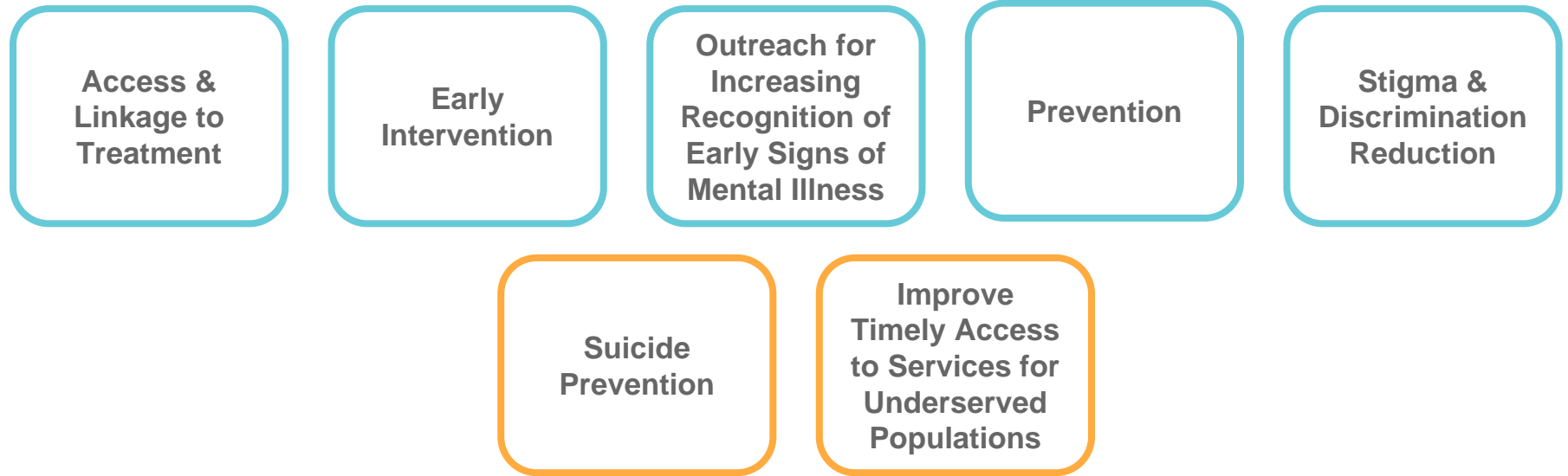

The MHSA Story

- Early Advocates Intent
 - Transform mental health care system
 - Address core issues arising from disinvestment in Mental Health
 - Close service gap for individuals with SMI and SED, while also supporting prevention, early intervention, and innovation
- MHSA Success & Visibility
 - Dedicated and growing funding source for mental health services, even during budget cuts
 - Unique prioritization of community engagement
 - Close-review of PEI programs

PEI Annual Report: Data Requirements

- Unduplicated numbers served
- Participant demographics
 - Age range, race, ethnicity, language, gender identity, sexual orientation, military status, disability status
- Activities, including success & challenges
- Anticipated activities and numbers served in upcoming FY
- Adherence to MHSA General Standards
- Budget
- Unique requirements for programs under the following service areas/program types:
 - Outreach for Increasing Recognition of Early Signs of Mental Illness
 - Access and Linkage to Treatment
 - Improve Timely Access to Services for Underserved Populations
 - Integrated programs

Some of these data points are challenging to collect!

If your program is unable to report on something that's okay, it just needs to be explained.

PEI Annual Report: Reporting Requirements by Service Area

Unique requirements for programs under the following service areas/program types:

Outreach for Increasing Recognition of Early Signs of Mental Illness

- # potential responders
- Setting in which potential responders were engaged
- Types of potential responders engaged in each setting

Access and Linkage to Treatment

- # individuals with SMI referred to county *and* non-county mental health treatment
- For county treatment:
 - # who engaged in treatment
 - Time from referral to treatment
 - Duration of untreated mental illness

Improve Timely Access to Services for Underserved Populations

- Population for which the program increases access
- # referrals to a PEI program, or treatment
- Time from referral to service participation
- Description of how service access and referral follow-through was encouraged

Integrated Programs

- Description of how service areas were integrated
- Description of how program will help improve access to services for underserved populations & use non-stigmatizing and non-discriminatory practices
- # of children, adults, and seniors to be served

PEI Three-Year Evaluation: Data Requirements

- Outcomes & Process for Collecting Data
 - Decrease in negative outcomes
 - Reduction in risk factors, or symptoms
 - Increase in protective factors
 - Improved recovery
 - Impact on systems
- Unduplicated numbers served
- Participant Demographics
- Activities, including success and challenges
- Anticipated activities and numbers served in upcoming FY
- Budget

Collecting outcome data might be new for some programs!

If your program is not yet able to report on outcomes that's okay, you just need to explain how you're preparing to collect this data in the future.

CSS: Data Requirements

- Unduplicated numbers served
- Participant demographics
 - Age range, race, ethnicity, language, gender
- How programs reach underserved populations and reduce disparities
- Activities, including success & challenges
- Anticipated activities and numbers served in upcoming FY
- Budget

The CSS and PEI reporting requirements are slightly different!

To support consistent reporting and allow for comparisons across programs, Lake County collects similar data across all CSS and PEI programs.

New Reporting Tools

Participant and Demographics Survey

- SurveyMonkey
- Data to report on:
 - Numbers served
 - Demographics
- Completed 2x per year
 - January – Data from Q1 & Q2 (July – Dec)
 - July – Data from last complete fiscal year

Activities and Outcomes Form

- Google Docs
- Data to report on:
 - CSS & PEI
 - Program activities from last FY
 - Anticipated upcoming activities and number to be served
 - Program outcomes
 - PEI Only
 - Adherence to MHSA General Standards
- Completed 1x per year
 - July – Data from last complete fiscal year

Reporting Timeline

The reporting deadline for fiscal year 2019/2020 is March 31st!

The new survey and forms are ready to be completed. Programs that already completed the old survey do not need to complete the new survey. All programs do need to fill out the new Google form.
